Access to Conversion

Access to Conversion can be ordered through **IGA** system except for special access user groups that are ordered via **Scania Now**. Some basic accesses (vera_users, conversion_parts_specialist, Conversion_xxxxx) can be ordered by your Local Group Administrator/IT manager through IGA.

This document describes the different user access groups that are available for Conversion users of Conversion Workshop client, Conversion Local Technical Helpdesk client and Conversion Global Technical Support client.

Every market may decide how to distribute membership to the access groups. In some instances, access has to be approved by Scania, see chapter **Special access user groups** below.

Basic access groups

As a Conversion user depending on your needs, we recommend you one of the following role packages.

Conversion xxxxx

All Conversion users need the access role "Conversion_xxxxx", where the five-digit number (xxxxx) corresponds to "Delivery customer number" for invoicing.

A user has to have at least one customer number at Scania (Dealer number or Distributor number) in order to access Conversion clients.

A user will be able to perform conversions for all the customer numbers that he is registered to. If the user has more than one customer number he will have to choose what customer number he is performing the conversion for.

Conversion_xxxxx access needs to be ordered separately since it is unique for each workshop/dealer/distributor.

It is not a part of the package available in IGA.

Following preconditions should be fulfilled in order to be granted access:

Check that the user is working at the accurate workshop/dealer/distributor

Access is granted by: Corporate approver (Conversion team) or your local IT manager

CONVERSION FOR WORKSHOP BASIC

Role names in IGA:

- Conversion Workshop Basic Owned Dealer must be ordered together with a Conversion_xxxxx access
- Conversion Workshop Basic Independent Dealer must be ordered together with a Conversion_xxxxx access

The user is able to order packaged conversions, order key codes, communicate with LoTH within the Conversion Workshop client. The user is not able to approve packaged conversions.

Same accesses for both independent and captive dealers. Depending on your position if you belong to Independent dealers you should select the role "Conversion

Same accesses for both independent and captive dealers. Depending on your position if you belong to Independent dealers you should select the role "Conversion Workshop Basic Independent Dealer" in IGA or if you belong to Captive dealers you should select the role "Conversion Workshop Basic Owned Dealer".

Name in Scania Now: Conversion Power Adaptation for distributors, Power solutions

(name in IGA/Conversion Admin - Conversion_EnginesEmission_Rebuilder)

The user access group Conversion Power Adaptation for distributors, Power solutions is required to be able to place orders for power-changing conversions for Power Solutions. This role is used by Distributor to adapt engines by changing engine output (kW) according to the customer needs before delivery.

This role is restricted and approval needs to be granted by Head of Service at Power Solutions.

Name in Scania Now: Conversion Market Adaptation approver, Trucks (name in IGA/Conversion Admin - Conversion_DESC_Rebuilder)

The user access group Conversion Market Adaptation approver, Trucks is required to be able to approve rebuilds affecting emissions for Scania vehicles. Commonly used for selling used vehicles to markets with different emission regulations or for emergency and military user groups with exemptions from emission regulations.
